I understand that in order to remain in good standing with White Tiger, this leave must be conveyed verbally or in written form to my instructor. In the event of a necessary leave of absence (extended illness, injury, or some other agreed upon leave), I may resume training under a "new contract" at a later date. All fees for training, membership, competition and equipment such as sparring gear, weapons, uniforms, patches and other related items are NON-REFUNDABLE.

In consideration of being allowed to participate in any way in the White Tiger Martial Arts Association program and related events and activities, the undersigned:

1. Agrees that they as a participant or the parent (s) or legal guardian (s) of the minor participant will abide by and/or instruct the minor participant to abide by the rules of both the White Tiger Martial Arts Association and the facilities which these classes or events are to be held.

2. Understands that training and competition in the martial arts involves physical contact and these classes are being taken at their own risk. They are fully aware of their personal medical condition and hereby certify that they are mentally and physically fit to participate in the martial arts.

3. Agrees to voluntarily disclose: Prescribed medication (s) that may impair reaction time or judgment., Suffered any incapacity requiring medical attention in the last 12 (twelve) months. Ever been excluded from martial arts in the past by a medical practitioner or martial arts club/individual.

4. Acknowledges and fully understands that each participant will be engaging in activities that involve risk of serious injury, including cuts and bruises, sprains, "Jamming" the fingers and toes, head injuries, broken bones, concussions, spinal injuries, permanent disability and death, and severe social and economic losses which might result not only from their own actions, in-actions or negligence but the actions, in-actions or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not known to us or not reasonably foreseeable at this time.

5. Assumes all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.

6. The applicant for himself/herself, his/her executors, administrators, dependents and other personal representatives hereby absolves and indemnifies the White Tiger Martial Arts Association, and it's servants agents, employees and other students or persons under it's control. The participant agrees to release, waive, discharge and covenant not to sue the White Tiger Martial Arts Association, its affiliated schools, their respective administrators, directors, agents, instructors, and other employees of the organization, other participants, sponsors, advertisers, and, if applicable, owners and leasers of premises used to conduct the classes or event, all of which are hereinafter referred to as "indemnified" from any and all liability to each of the undersigned, his or her heirs and next of kin for any and all claims, demands, losses or damages on account of injury including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the indemnified or otherwise.

7. Furthermore, hereby permanently waives any compensation for the use of pictures, videos, media coverage, etc. that may be used for profit making purposes.
